We acknowledge that this information is for initial planning purposes only, with division allocations solely at the discretion of the EDPL Executive, using player points as reference and taking in to account what divisional structure better suits the league overall.

Submission of this form indicates our club's agreement and acceptance the following:

- A minimum of 2 tables are required for teams in Premier, 3rd or 4th Division.
- A minimum of 3 tables are required for teams in 1st or 2nd Division.
- A set of tables, in accordance with the above two points, can only be assigned to a maximum of two teams.
- Clubs must have own constitution (a current copy to be supplied to EDPL), along with a bank account in club's name, with a minimum of two signatures for cheques from a panel on not less than three signatories.
- Clubs are required to be an "Incorporated Association" as defined by Victorian State Law. Copy of Incorporation Certificate to be produced on request.
- Clubs are required to have an elected Committee, complete and submit an EDPL "Club Executive Listing" form no later than the first playing week of new Winter Season (preferred by end of February).
- Clubs will elect a delegate and an optional proxy delegate from their own elected committee who will represent their club at EDPL committee/delegate meetings, and be authorised to vote on their clubs' behalf.
- Clubs acknowledge that they are bound by the Constitution and By-Laws of the EDPL at all times.
- Clubs agree to follow the World Eight-Ball Pool Federation playing rules as set down in EDPL Handbook.
- It is agreed that players will be available to fill each team prior to the start of the season
- Clubs not complying with any of the above requirements at any time may see their registration revoked.
- **\$75.00 per team application fee will be billed to the club as part of their monthly invoice**
