PLAYERS AND UMPIRES - PLEASE NOTE:

FINALS DRESS-CODE – *By-law 4.5.2 – EDPL members participating in Winter finals or EDPL Tournaments (either as a player, official or umpire), must wear either black slacks OR a black skirt with black stockings, along with black business shoes and club/exec shirt **ALL BLACK RUNNERS allowed!** (caps, beanies, denim, suede and runners with any color/white are not acceptable).*

ALL BLACK RUNNERS & NEAT BLACK JEANS / CHINOS ARE PERMITTED THIS YEAR AT FINALS!
If a Dress-Code exemption is required, must lodge request with medical certificate to office well PRIOR to finals!

PERSONS NOT ADHERING TO FINALS DRESS-CODE WILL NOT BE PERMITTED TO PLAY OR UMPIRE.
